

# Certification: Requirements and Procedure

## Development Path

### for certification to facilitate the workshop inter-generational dialogue (Generationen im Dialog®)

#### 1. Preparation Phase – Requirements for Subsequent Granting of Usage Rights for the Workshop Concept

##### 1.1 Workshop Participation

- At least one-time participation in the inter-generational dialogue workshop Generationen im Dialog® (hereafter briefly referred to as inter-generational workshop with a family member (parent or child).
- If participation is not possible, two additional assistances may substitute this requirement.

##### 1.2 Professional Qualifications

- At least five years of licensed practice as a psychotherapist or clinical psychologist, including proof of ongoing professional experience.

##### 1.3 Workshop Assistance

- Three instances of assistance under certified workshop facilitators. A list of certified workshop facilitators can be found on the website [generationen-dialog.com](http://generationen-dialog.com).
- Assistance sessions must be completed under at least two different teams of workshop facilitators.

##### 1.4 Reflection and Self-Assessment

- Submission of a written reflection on personal experiences and qualifications relevant to facilitating an inter-generational workshop.
- The reflection must be provided to the certified workshop facilitators.

##### 1.5 Declaration of Commitment

Written commitment from the candidate ensuring the workshop concept and related workshop materials will neither be professionally utilized nor disseminated prior to completing their certification. (Note: Upon certification, usage and dissemination are permitted in compliance with the stipulations outlined in the finalized agreement.)

#### 2. Transfer of Usage Rights

##### 2.1 Review by the Quality Assurance Committee

The Quality Assurance Committee reviews the application and the fulfillment of all prerequisites.

##### 2.2 Confirmation of Review Results by Dr. Sabine and Roland Bösel

Dr. Sabine and Roland Bösel are automatically informed of a positive review result by the Committee. Provided no objections arise, they give definitive approval for certification.

##### 2.3 Confirmation

Issuance of a certificate authorizing the use of the workshop concept and related materials—provided all conditions specified in a separately concluded agreement are consistently met. One

such condition is the requirement that workshops must always be conducted jointly with a likewise certified co-facilitator.

## 3. Post-Certification: Duties of Certified Workshop Facilitators

### 3.1 Workshop Execution

- Workshops must only be conducted in cooperation with a second certified co-facilitator.
- Prior to the public announcement of the first independently organized workshop, location, date, and co-facilitator must be communicated to Dr. Sabine and Roland Bösel.

### 3.2 Transparency and Copyright

- Recognition of Dr. Sabine and Roland Bösel's authorship of the concept, ideas, and materials for the inter-generational workshop (Generationen im Dialog®) workshop.
- This authorship must be clearly indicated on all documents used within the workshop and on all promotional materials announcing the workshop.

### 3.3 Responsibility

- Independent execution of workshops according to professional ethical standards.
  - No mutual liability between contractual partners.
- 

## 4. Quality Assurance and Continuous Development

### 4.1 Reflection After First Workshop

- Submission of a written reflection on the process and experiences of the first workshop to the Quality Assurance Committee.

### 4.2 Qualification of New Assistants

- The certification also entitles the holder to qualify new assistants.
- Prior to their first assistantship, each new assistant must sign the written "Agreement for Assistants," and a copy must be sent to Dr. Sabine and Roland Bösel
- The Agreement for Assistants may be updated occasionally; always use the latest version. (Dr. Sabine and Roland Bösel will endeavor to inform certified facilitators promptly of any updates. Certified facilitators are encouraged to inquire proactively if uncertain.)

### 4.3 Networking and Cooperation

- Collaboration and exchange with other certified workshop facilitators for ongoing quality assurance and improvement.
- Optionally, facilitators can join one of our international WhatsApp groups (available in English and French).
